## The Background...



- 2005 Tewksbury Long Range Planning Study Committee retained SMMA to evaluate the condition of the Town's 4 elementary schools and the high school
- 2006 SMMA's Master Plan Study recommended:
  - New (replacement) of the:
    - North Street School (1952)
    - Trahan School (1954)
    - Heath Brook School (1956)
    - TMHS (1958)
  - Additions and renovation to the Dewing School (1968)

# The Background...



- 2007-2012 The New TMHS is funded and built (from feasibility to completion)
- 2011- Tewksbury Board of Selectmen (BOS) and Tewksbury School Committee (TSC) formed the Tewksbury School Facilities Study Committee (TSFSC) to:
  - Review and validate the 2006 SMMA Master Plan Study
  - Review and evaluate current conditions of the 4 elementary schools
  - Review enrollment data
  - Provide a recommendation to the BOS and TSC

#### TSFSC Recommendations...



- 2012 The TSFSC reported to the BOS and the TSC:
  - SMMA's recommendations are still accurate
  - New (replacement) elementary schools are still needed



- TSFSC (replacement) configuration recommendations:
  - Construct 1 new school for grades 1-4; renovate the Dewing School for Pre-K-& Full Day K
  - Construct 2 new K-4 elementary schools
     (1 on South side, and 1 on North side)
  - Construct 1 Pre-K-4 new school
  - Construct 4 new K-4 elementary schools
  - ...and other options yet to be defined




#### Where We Are Now...

## The Eligibility Period...






#### 270 Day Eligibility Period
