# **CALL TO ORDER**

Ms. Polimeno called the April 26, 2017 Regular School Committee meeting to order at 6:30 p.m.

#### RECOGNITION

### U.S. Presidential Scholar Nominees – Sara Catanzano & Nicholas Zullo (TMHS Seniors)

Mr. Malone introduced Nicholas Zullo and Sara Catanzano recognizing their exceptional talent. Ms. Vogel presented Nick and Sara relating they were selected as U.S. Presidential Scholar nominees the national level competition. On behalf of the School Committee, Mr. Sullivan presented Mr. Zullo and Ms. Catanzano with a Proclamation of Recognition.

Ms. Polimeno addressed the students stating that they are great examples of what we want the children of Tewksbury to be. She added that Nick and Sara are truly role models and we all appreciate everything they have done at Tewksbury Memorial High School.

### **Lifetime Achievement Award - Mary Eldringhoff**

Mr. Malone introduced Mary Eldringhoff to the School Committee and community. Ms. Vogel was asked to say a few words relating that Ms. Eldringhoff is the recipient of the Peggy Hallisey Lifetime Achievement Award. # Elementary Schools: Dewing/Heath Brook/North Street/Trahan

Ms. Gerrish and Ms. Wettstone, Mr. Castonguay, and Ms. Kimble addressed the School Committee presenting the 2017-2018 Elementary Schools Handbook. Ms. Kimble introduced the elementary school handbook presentation relating the handbook is the result of a unified effort to collaborate on the handbook. Ms. Wettstone related they developed one handbook for all four schools. The principals pointed out the revisions to the 2017-2018 elementary student handbook. They are working with Ms. Rauseo, in Community Services, to access the handbook online as well as being able to do a digital signature.

Ms. Polimeno reported the Committee has read the handbook and suggested a few revisions. The School Committee commented on the handbook content relating that it is wonderful to see all four principals working together and developing one handbook. Mr. Malone reported meeting with the Town-wide PAC on April 10, 2017 presenting them with information from the Massachusetts School Building Authority (MSBA). He reported the district received suggestions from the PACs relating that they will help mobilize parents and get the information out.

She reported that the Advisor Council helped to update the annual Professional Development Staff Survey looking at goals, areas of improvement, and what teachers are looking for in professional development for next year.

Ms. Regan reported the district has provided the School Committee members with a Google end-of-year calendar in order to keep the Committee apprised of end-of-year events.
