CALL TO ORDER

Ms. Polimeno called the January 24, 2018 Regular School Committee meeting to order at 6:00 p.m.

Ms. Polimeno announced the School Committee will be convening an Executive Session to continue discussion relative to strategy with respect to collective bargaining or litigation.

Mr. Francis moved, seconded by Ms. Bennett, to enter into an Executive Session to continue discussion relative to strategy with respect to collective bargaining and/or litigation. The School Committee will reconvene in Open Session at 6:30 p.m.

Roll Call Vote: Voting Yes: Mr. Sullivan, Mr. Cutelis, Mr. Francis, Ms. Bennett, and Ms. Polimeno. All Aye. No Opposed. Unanimous Vote. Motion carried 5-0.

At 6:25 p.m., Mr. Francis moved, seconded by Ms. Bennett to adjourn the Executive Session and reconvene the Regular School Committee meeting. All Aye. No Opposed. Unanimous Vote. Motion carried 5-0.

BUDGET WORKSHOP

At 6:35, Ms. Polimeno called the January 24, 2018 Budget Workshop to Order. Mr. Malone introduced Ms. Matthews, Director of Business Services.

Ms. Matthews addressed the School Committee stating that the purpose of the Budget Workshop is to give the School Committee and the public an overview of the preliminary FY19 Budget and the process of developing it. The budget narrative summarizes the budget needs and presents the history of the overall budget. The School Committee may ask for revisions to the presented budget in which Ms. Matthews will make the appropriate updates for the Public Budget Hearing on March 7, 2018. Ms. Matthews presented the Fiscal 2019 (FY19) School Budget Summary.

APPROVED 3-14-2018

Ms. Matthews reported the goal of the Tewksbury School Committee is to provide a level of funding for our schools that ensures a sound instructional program for students and in being fiscally responsible for the taxpayers. Ms. Matthews reported the budget narrative summarizes the school needs and the how resources combine to meet those needs. She reported that this is a contract negotiation year and reflects only steps and lanes. Ms. Matthews reported on factors contributing to the FY19 budget: the renewal of the student specific needs contract relating there will be an increase, renewal of the transportation contract, renewal of the anti-virus contract which we will see an increase, increase in the special education out-of-district account, and a decrease in the Circuit Breaker. Ms. Matthews presented the requested new staff by location. She reported the proposed budget summary school appropriation for salaries, operating cost and capital outlays is \$46,914,229.00, a 3.19% increase, Total Fixed Cost is \$10,377,542.00, 2.08% increase, with a total budget of \$57,291,771.00 which matches up with the recommendation of the Town Manager and was presented to the Board of Selectmen. Ms. Matthews entertained questions from the School Committee.

At 7:15 p.m., Mr. Francis moved, seconded by Ms. Bennett to adjourn the Budget Workshop and reconvene the Regular School Committee meeting. All Aye. No Opposed. Unanimous Vote. Motion carried 5-0.

Notes From Tewksbury Memorial High School

Grace Morris reported on the news from Tewksbury Memorial High School:

- International Club are in the process of collected shoes for Soles for Souls and are very grateful for their donations.
- DECA is getting ready for State Conference on March 8, 9,10 in Boston.
- Student Council are working with DECA to plan a date for Mr. TMH, and they are excited for their MASC Conference.
- Best Buddies are doing movie night on Thursday and are traveling to the Unified Bocce Tournament on Sunday.
- ECHO are crafting blankets and scarves on the 31st for a charity that they have not decided upon yet.
- SADD are working on the dating game, which they hope will present a positive message of the importance of healthy relationships.
- Math Team Last thursday, they travelled to Westford for a competition that they came in 3rd behind Westford and Andover, with their highest score ever in the math team history. They defeated Central Catholic, North Andover, Billerica, North Middlesex, and Lowell.
- Mock Trial have their first Trial on Friday at the Northeast Housing Court in Lawrence against Chelmsford, and they are very excited.

PRESENTATIONS

ACE Program Presentation (Piloting the program, researched based) - Special Education

Mr. Pelletier addressed the School Committee reporting on the ACE pilot program relating that the district's Behavior Specialists and BCBA's continue to make improvements across the district increasing behavioral supports for all students, providing improved services in the DLC centers, and working collaboratively with faculty, staff, and administrators to align services. Mr. Pelletier reported that the Autism Curriculum Encyclopedia (ACE) program is a software system program which provides an individualized approach to student learning, involves and engages active learning for students, with data driven resources, and an online access to assessments and data analysis. The district revised the Entitlement Grant to provide the pilot program to more students.

Mr. Pelletier introduced Laura Lemke, BCBA for PreK-6, DLC-BCBA program Ms. Lemke addressed the Committee presenting the ACE Program, an ABA software system created by the New England Center for children for teachers and related service providers to find an ABA-based program for children who require individualized instruction and supports. Ms. Lemke presented a sample lesson plan and features of the ACE program which offers progress monitoring tools to assist children in meeting IEP goals, training, and supports data for staff and parent. She reported we have begun staff training and Professional Development opportunities will be held in the Fall. Ms. Lemke entertained questions from the School Committee.

Mr. Malone remarked that ACE is an aggressive program typically offered in out-of-placement environments relating that if the district did not invest in the technology last year, this would not have been possible. Mr. Malone offered *Hats Off!* to the Special Education Department for trying the program and bringing specialized instruction to students. Ms. Bosworth reported the district will pilot the program next year with up to 40 students, parent meetings are scheduled at the end of February, then meetings with other Learning Center staff, and the plan will be rolled-out in the Fall to the students identified. Ms. Polimeno invited Ms. Lemke to a School Committee meeting next Fall for an update.

Mr. Malone requested to move New Business item, #1 Kindergarten Information Night, to this portion of the meeting. Mr. Francis moved, seconded by Mr. Sullivan. All Aye. No Opposed. Unanimous Vote. Motion carried 5-0.

New Business

Kindergarten Information Night

Ms. Gerrish, Ms. Fuller, and Ms. Wettstone addressed the School Committee presenting the 2018 preschool and kindergarten Information update. Ms. Fuller reported the schools reached out to all families with three and four year old regarding preschool opportunities and held two information sessions on January 23, 2018 relating we had a good turnout with 45 adults representing 25 families at the first session and 55 adults at the evening meeting. She reported that preschool registration opened today. Ms. Fuller entertained questions from the School Committee.

Ms. Gerrish and Ms. Wettstone reported on the upcoming kindergarten registration. Ms. Gerrish reported that postcards were sent to 163 families from the Dewing School and over 90 families form the Heath Brook School.

Ms. Wettstone presented the kindergarten timeline reporting a kindergarten informational night will be held on February 6, 2018, 6:30 p.m., at Tewksbury Memorial High School, registration will be held daily March 5th through March 9th and will also be available one night during that week, screenings will be scheduled in April, in June class lists go home, teachers will mail letters home the week of August 7th, and Kindergarten Orientation/Open House will be held on August 27, 2018.

Ms. Gerrish and Ms. Wettstone entertained questions from the School Committee.

SUPERINTENDENT REPORTS

Mr. Malone presented the Superintendent's Report:

Mr. Malone offered a thank you to the Tewksbury SEPAC for hosting the Meet and Greet last week relating there was a good discussion on what is happening in the district.

Mr. Malone reported on the weather and the teamwork across the district when the North Street School was without power. Mr. Malone reported the district called a 2-hour delay of school at the North Street waiting for the power to return. He reported while waiting for the power to be restored a generator was brought in as well as a hotspot for wireless relating that the staff was prepared to hold school in a building without power. The power was restored at 9:00AM. Mr. Malone thanked the Tewksbury DPW for clearing roads and parking lots and to the district's maintenance staff for clearing walkways. Mr. Malone remarked that people responsible for safety in the district to a great job and that it speaks of the collaboration with the Town.

Ms. Regan Presented the Assistant Superintendent's Report:

Ms. Regan announced that report cards will be distributed on February 2, 2018. She reported that all ELL students have completed the online assessments. Ms. Regan thanked the Town for supporting new staff in the district reporting that on the Consent Agenda the Committee will notice the hiring of Jenn Espaillat to the ESL department and Jessica Simpson has moved into the new position of K-12 Integrated Technology Specialist relating that Emma Sweetapple was hired in the position Jessica held at the high school in Digital Media/Instructional Technology Teacher. Ms. Regan announced that tomorrow is a half-day Professional Development day reporting on the PD offerings. She added that the Learning Center teachers will be trained on the ACE program.
