CALL TO ORDER

Ms. Polimeno called the March 20, 2019 Regular School Committee meeting to order at 5:30 p.m.

EXECUTIVE SESSION

Ms. Polimeno announced the School Committee will be convening an Executive Session to continue discussion relative to collective bargaining with employee groups and the strategy to be followed and/or continued ongoing litigation. The School Committee will reconvene in Open Session for the Budget Workshop at 6:30 p.m.

Mr. Francis moved, seconded by Ms. Bennett, to enter into an Executive Session to continue discussion relative to collective bargaining with employee groups and the strategy to be followed and/or continued ongoing litigation.

Roll Call Vote - Voting Yes: Mr. Sullivan, Ms. Bennett, Mr. Francis, Mr. Cutelis and Ms. Polimeno. All Aye. No Opposed. Unanimous Vote. Motion carried 5-0.

At 6:30 p.m., Mr. Francis moved, seconded by Ms. Bennett, to adjourn the Executive Session and reconvene the Regular School Committee meeting. All Aye. No Opposed. Unanimous Vote. Motion carried 5-0.

Public Budget Hearing

At 6:34 p.m., Ms. Polimeno opened the March 20, 2019 Public Budget Hearing, announcing the public is welcome to ask questions and/or comments relating that all comments and/or questions should be directed to the Chair. Ms. Polimeno reported that the School Committee will not respond to questions this evening.

Mr. Libby addressed the School Committee presenting the FY20 Public Budget Hearing reporting that this is the third budget presentation relating the budget has been presented to the Tewksbury Finance Committee. Mr. Libby reported the District Strategy is the driving force behind budget decisions in the district.

He reported the budget is made up of four areas, three are managed by the district, salaries, operating costs, and Capital Outlay, and fixed costs are shared with the town. Mr. Libby reported he met with the principals and the leadership team looking at common areas of focus: technology, building improvements, and personnel. He reported the district is looking at a 2.83% increase which is in-line with the Town Manager's recommended budget for the district. Mr. Libby reported that changes have been made to the bottom line due to enrollment at Shawsheen Technical High School and the Valley Collaborative, as well as adjustments to Circuit Breaker budget due to the Governor's budget. He reported that adjustments expected to salary figures due to personnel decisions. He stated that the school department is requesting a 1.92% overall increase to fixed cost and \$948,000 in Capital Outlay for technology infrastructure upgrades. Mr. Libby reported the Tewksbury Public Schools is eligible for \$384,000 through the E-rate funding relating that the district has to have the projects fully budgeted to qualify. Mr. Libby presented the capital and maintenance projects throughout the district and presented the grant funding three year history. He reported the district has seen cuts in Title 1; the costs had to be absorbed into the regular budget. He reported the next steps are to continue discussion with principals, department heads and town officials to assess needs, to look at our focus areas, and to refine numbers as we approach the May Town Meeting. Mr. Libby feels the district can work within the budget of \$62,000,000.

Mr. Libby addressed questions and comments from the School Committee and the audience.

At the recommendation of Ms. Polimeno, Mr. Francis moved, seconded by Ms. Bennett, to close the Public Budget Hearing for the 2019-2020 school year budget. All Aye. No Opposed. Unanimous Vote. Motion carried 5-0.

The Committee took a five minute break and returned to the Regular School Committee meeting.

Mr. Oliva reported that the national essay contest is about patriotism and that this year they had the most applications than over the past five years relating that the top three winners of the Patriot Pen, at the District level, are Tewksbury students. Mr. Oliva introduced Brooke Bunyan, second place winner, presenting her with a Certificate of Merit and a check. Brooke read her essay to the School Committee and community. Mr. Oliva introduced Morgan Kelly, the first place winner, presenting her with a Certificate of Merit and a check. Morgan read her essay to the School Committee and the community. The third place winner, Ava Konaxis, was not able to attend tonight. On behalf of the students and staff, Mr. Malone thanked Arthy and presented a video recognizing Arthy. Ms. Bennett was presented with gifts from the Robotics Team and flowers from the district and the Committee. Ms. Bennett addressed the Committee and the community thanking them for the opportunity to serve Tewksbury. The Committee thanked Krissy Polimeno for serving on the Committee and for her leadership. Mr. Malone presented Krissy with flowers and for her involvement in the basketball program, she received an autographed basketball. Ms. Polimeno was presented with the first annual Krissy Polimeno Educator award. Ms. Polimeno addressed the Committee relating that she has enjoyed last nine years, she is proud of everything accomplished, and believes in the Tewksbury Public Schools.

SUPERINTENDENT & STAFF REPORTS

Mr. Malone reported Channel 5 recognized two students from Tewksbury Memorial High School that will be going to Kenya to volunteer. Mr. Malone reminded the School Committee and community members that Alphabest will be working with families on summer programming and enrichment opportunities. They are holding a staff recruiting event at the Wynn Middle School tonight and will be communicating out information regarding to parents and guardians. He reported that he and Kristen Vogel attend a youth vaping institute regarding vaping issues, they looked at models from other schools relating that data shows how dangerous the epidemic is for children. Mr. Malone presented sports updates reported the TMHS Girls Basketball team and the Boys Hockey Team reached the Division finals this year and the Girls Hockey team won the Division 1 State Championship at TD Gardens. Mr. Malone reported the School Committee will recognize them at the April meeting.

Ms. Regan, Assistant Superintendent

Ms. Regan reported that March 4th through March 14th, 76 students completed voter registration applications at Tewksbury Memorial High School, thanking TMHS senior, Roslyn Impink, and Brian Aylward, for continuing to bring this opportunity to TMHS. Ms. Regan reported that she attended the Cultural Fair on March 26th and 27th, thanking the Foreign Language Department. She reported on March 26th & 27th, 10th graders will be taking English Language Arts (ELA) Next Generation online MCAS testing. Grades 9th, 11th, and 12th grade students will have a full day of school. On March 26th Jessica Minahan will provide a full-day professional development workshop for our administrator teams and select service providers an BCBA's.

David Libby, Business Manager

Mr. Libby reported the district continues to work with transportation vendor improving the "Where is the Bus" application for parents and guardians. He remarked that the district is working to improve bus services for parents in order to alleviate traffic issues.

Elementary School Building Committee (ESBC)

Mr. Francis reported the ESBC schematic design end on May 6th Town Meeting vote. Mr. Frances announced the latest activities and reported on the Project Scope. Mr. Francis reported the next meeting will be held on April 4, 2019 at 6:00 p.m. Next Tuesday, March 26th, the ESBC will be making a presentation at the Tewksbury Board of Selectmen meeting relating that all other boards in the town were invited to attend the presentation. He reported the ESBC continues to remain focused on their mission statement and working with neighbors.

Mr. Sullivan reported the next Wellness Advisory Committee meeting will be held on May 20th.

2019-2020 School Calendar Draft

Ms. Regan pointed out an update to the 2019-2020 school calendar reported the May workshop day was moved from Friday, May 7th to Thursday, May 6th. Another edit was made to adjust the early release end time for some schools reporting that a student day is 6 hours 20 minutes across the district, the half-day is 3 hours 10 minutes. A vote from the School Committee was needed to accept the changes to the 2019-2020 school calendar.

Ms. Bennett moved to approve the updates to the 2019-2020 school calendar, seconded by Mr. Sullivan, to move the Workshop day to May 6, 2020 and to adjust the early release hours for the Ryan Elementary School, the Wynn Middle School, and at Tewksbury Memorial High School.

Mr. Francis reported that he attended the National Honor Society induction at TMHS relating it is great seeing students recognized. Ms. Polimeno thanked the Committee for the support of her and wish nothing but the best for the Tewksbury Public Schools.
