## The following documents MUST BE PRESENTED AT REGISTRATION

- 1. Proof of Residency (New lease/Fully executed purchase and sale or recent mortgage bill/statement with names and new Tewksbury address)
- 2. Proof of Occupancy (current electric, gas, cable or land-line telephone bill <u>cell phone and water bill are</u> ...<u>not accepted at this time</u>).
- 3. Original Birth Certificate with raised seal (not Hospital Birth Certificates) must be presented at registration. Your child must be 5 years old as of August 31, 2020.
- 4. Parent/Guardian photo identification (driver's license with current Tewksbury address).
- 5. \*Immunizations and Current Physical (or proof of appointment) must be up-to-date and presented at registration.
- 6. The registration packet that includes forms such as accident/illness, language survey, etc.

## \*MINIMAL IMMUNIZATION REQUIREMENTS FOR KINDERGARTEN

\* DTP - 5 doses

- \* Polio 4 doses
- \* Hepatitis B 3 dose series
- \* Lead Screening
- \* Vision Screening
- \* Recent Physical Exam

\* MMR - 2 doses \* Varicella - 2 doses or MD note verifying child has contracted Chicken Pox
