CALL TO ORDER

Mr. Sullivan called the February 12, 2020, Regular School Committee meeting to order at 6:00 p.m. Mr. Sullivan announced the School Committee will be convening an Executive Session to continue discussion relative to collective bargaining with employee groups or individual employees and the strategy to be followed, and/or continued ongoing litigation.

Mr. Cutelis moved, seconded by Ms. Demos, to enter into an Executive Session to continue discussion relative to strategy with respect to collective bargaining and/or litigation. The School Committee will reconvene in Open Session at 6:30 p.m. for the Budget Public Hearing.

Roll Call Vote - Voting Yes: Mr. Wilson, Mr. Stadtman, Mr. Cutelis, Ms. Demos, and Mr. Sullivan. All Aye. No Opposed. Unanimous Vote. Motion carried 5-0.

At 6:25 p.m., Mr. Cutelis moved, seconded by Ms. Demos, to adjourn the Executive Session to convene a Public Hearing on the budget and reconvene the Regular School Committee meeting. All Aye. No Opposed. Unanimous Vote. Motion carried 5-0.

PUBLIC BUDGET HEARING

At 6:34 p.m., Mr. Sullivan opened the February 12, 2020 Public Budget Hearing.

Mr. Libby addressed the School Committee presenting the FY21 Budget reporting that the budget consists of four major parts, salaries, operating costs, Capital Outlay, and fixed costs. The fixed costs are managed and shared with the town. Mr. Libby presented an overview of needs and the focus areas across the district in personnel, technology and building improvements. He stated the overall increase in the school budget is 2.03%. The salaries are 70% of the school budget, assuming level staffing, which includes, salary increases, steps, longevity, and contractual increases. The operating budget is 28% of the school budget. Most of that budget is in transportation and tuition.

Capital Outlay is 2% of the school budget for textbooks and software, maintaining our buildings, technology upgrades, and to accomplish items on the project list. Mr. Libby presented the E-Rate update, funding earmarked for school projects, costs savings we had due to work the IT department staff completed, and the completed project list. Mr. Libby presented the grant funding and Title 1 update and reported that at the request of the town, the district has reduced the number of revolving accounts from 89 to 62.

Mr. Libby reported the recommended FY21 school budget is \$50,633,725.00: salaries are \$35,205,417, operating costs are \$14,578,308, the Capital Outlay is \$850,000, and fixed costs are \$10,553,341. He reported the next step in the budget process is to continue discussion with building principals, department heads, school staff, elected and town officials, and community members. Mr. Libby concluded with a call for questions and/or comments from the School Committee.

Mr. Stadtman updated the community on his suggestion to look at a Warrant Article for school roofs at the Heath Brook and Ryan Schools. He reported we met with the Town Manager regarding a Warrant Article for school roofs and we will not go forward with a Warrant Article at this time. Mr. Libby provided an update on the roofs at the Ryan School and the Heath Brook School.

Mr. Sullivan announced that this is a Public Budget Hearing, the public is welcome to make comments or ask questions. They may contact Mr. Libby or Superintendent Malone with any questions or comments. Mr. Sullivan asked if anyone had any questions on the Budget Hearing. Seeing no one, Mr. Sullivan called for a motion to adjourn the Public Budget Hearing.

At 6:58 p.m., Ms. Demos moved, seconded by Mr. Cutelis, to adjourn the Public Budget Hearing. All Aye. No Opposed. Unanimous Vote. Motion carried 5-0. Mr. Sullivan announced that the School Committee will reconvene in one (1)minute.

ANNOUNCEMENT

Mr. Sullivan reconvened the Regular School Committee meeting at 7:01 p.m. Mr. Sullivan announced that the February 12, 2020, Regular School Committee meeting will be televised and recorded. Under the Open Meeting Law, the public is permitted to make an audio or video recording of an open session at a public meeting. At this time, Mr. Sullivan asked if anyone is recording tonight's meeting to please identify himself/herself. Eric Kane and Matt Holmes, Channel 7 News, announced that they are recording the meeting.

Mr. Cutelis motioned to move the Program of Studies from New Business to this portion of the agenda. Mr. Wilson seconded. All Aye. No Opposed. Unanimous Vote. Motion carried 5-0.

Program of Studies

Ms. Regan reported the Committee has received a change memo for the TMHS 2020-2021 Program of Studies, pointing out the updates and revisions for the upcoming year. Mr. Sullivan opened for questions and/or comments from the Committee.

Ms. Demos moved, seconded by Mr. Wilson, to accept the 2020-2021 Program Of Studies as presented. All Aye. No Opposed. Unanimous Vote. Motion carried 5-0.

Mr. Sullivan announced that Superintendent Malone is attending a national conference sponsored by AASA this week.

SUPERINTENDENT REPORTS

Ms. Regan reported that last week she and Superintendent Malone visited the new K-2 DLC program at the Heath Brook School. Ms. Regan pointed out that the District Report card is on the Consent Agenda relating that a link to the District and School Report Cards may be found on the MA Department of Elementary and Secondary Education's (DESE) website. She presented an update on the Tiered Focus Monitoring (TFM), previously known as the Program Coordinated Review. She reported that DESE does a review of all Massachusetts' school districts in the areas of Special Education programming and compliance, Civil Rights, and English Language Learners. There were no issues of non-compliance found and the district is rated Tier 1 in all categories. Ms. Regan presented a snapshot of our website analytics from last year. She reported the TPS mobile app was updated to fix some glitches. Ms. Regan reported the Wynn Middle School is hosting the Unified Basketball Program this year, the TMHS Mock Trial Team had its first win over Chelmsford last week, the MIAA named Tori Schille as the January Athlete of the Month, and last week Channel 5 News recognized Jessica Driscoll, a sophomore at TMHS and a member of the Red Rangers Girls Ice Hockey Team, as she honored the memory of her late brother Ryan Driscoll at the last Red Rangers ice hockey game.

Ms. Regan reported the 100th day of school was last week. At this time of the year, the district will begin planning for the summer programs. She reported that last week kindergarten and preschool registration began. Our summer programming and planning is underway for summer school, AlphaBEST, and enrichment opportunities. Ms Regan reported the district received two grant awards from ExxonMobile in the amount of \$500.00 each. The donations will be used for the high school Robotics Club. She reported nominations are closed for the Ginsburg Award and we will make an announcement once the winner is chosen. Ms. Regan reported that March 13, 2020 is an early release half-day for students and a half-day Professional Development day for staff.

Mr. Sullivan opened for comments and/or questions from the School Committee. Mr. Sullivan took a moment to acknowledge the SEPAC members in the audience and thanked the SEPAC for their collaboration with the Unified Basketball program at the Wynn this year. He reported we are in the works of starting a similar program for the Ryan School adding that it should begin in March.

Mr. Libby, Business Manager Report

Mr. Libby reported that last year's winner of the Ginsburg Family award, Donna's Donuts, requested the \$5,000 award to be used to support music and the arts in the district.
