#### **CALL TO ORDER**

Mr. Sullivan called the March 3, 2021, Special School Committee meeting to order at 5:02 p.m.

Roll Call Vote: Voting Yes: Mr. Stadtman, Mr. Cutelis, Ms. Demos, and Mr. Sullivan. Unanimous Vote. Motion carried 4-0.

#### **ANNOUNCEMENT**

Mr. Sullivan reported that the March 3, 2021 Special School Committee meeting will be televised and recorded. School Committee Chairman, Keith Sulivan, confirmed that all members of the School Committee and persons on the agenda are present and give consent to be recorded tonight.

Mr. Sullivan stated that the March 3, 2021 is an open meeting. Due to the recent open meeting law policy set forth by the Governor during the current state of emergency the meeting will be held as a virtual meeting *via WebEx*.

Mr. Sullivan read the Governor's Order for conducting a remote meeting and the Tewksbury School Committee ground rules. The public was invited to pre-register to make a comment at tonight's meeting and/or make comments by calling in during the Citizen's Forum section of the meeting on 781-565-8134.

#### **DISCUSSION OF OPEN NEGOTIATIONS**

Discussion of Open Negotiations with the Tewksbury Teachers Association (TTA) specific to more In-Person time Learning.

Mr. Malone reported that the district is working with the TTA specifically to return to school this year and negotiating models and lately, on more In-person Learning time. We believe, from meetings with the TTA, that it is important to make sure we have staff input on all aspects of students returning to school. He related that Mr. Bilodeau, President of the TTA Union, is interested in open negotiations regarding more In-person time. With the collaboration of the TTA we are proposing open negotiations with the TTA and the Tewksbury School Committee and for the public to view the meetings live.

Mr. Malone responded to questions and comments from the School Committee. The School Committee members were in agreement and support of open negotiations for In-person Learning.

Mr. Wilson was experiencing technical difficulty and joined the meeting at 5:14 p.m. He was able to hear the meeting and agreed to the open negotiations.

Mr. Cutelis wanted to confirm that the Committee would be able to begin the open negotiations on March 4th, 2021.

Mr. Cutelis moved for the School Committee to engage in open communication with the Tewksbury Teachers Association (TTA) to negotiate more In-person Learning time, to begin immediately. Ms. Demos seconded the motion.

Roll Call Vote: Voting Yes: Mr. Stadtman, Mr. Cutelis, Ms. Demos, Mr. Wilson, and Mr. Sullivan. Unanimous Vote. Motion carried 5-0.

# **DISCUSSION OF PHASE-IN SCHEDULE**

Discussion Phased-In Schedule for the return of students to school.

Mr. Malone and Ms. Regan presented a presentation, More In-Person Learning Time for Our Students. The goal of the presentation is to propose an initial plan for a phased-in approach, specific to more In-person Learning for Tewksbury Public Schools' students and to further explore stakeholder input, solutions to obstacles, gathering information to support a formal plan to be voted on by the School Committee in a forthcoming meeting. Mr. Malone responded to questions and comments from the School Committee members. He will coordinate to have Ms. Demos do a walk-through in the schools to look at the classroom sizes and set-up for return of the students. The Committee members supported the proposed plan for students to return to school.

Ms. Gallant voiced her concern about coming back to school full in-person. Her concern is safety for teachers and aides and students and the spread of COVID.

Mr. Maciak inquired if the district would be able to offer before and after school programs/extended day for students.

Grace D'Ippolito, 11 Allison Way, Tewksbury

Ms. D'Ippolito inquired if the district would be offering summer classes for students. She also inquired if the district would notify parents when the phase-in would happen and if they would need to provide transportation for their children.

Ms. Coviello supports full in-person return to school. She commented that she was thrilled the vote for open negotiations between the School Committee and the TTA passed.

Ms. Kelly inquired about the phase-in schedule and why the middle school would not be in school full-time in May.

Mr. Sullivan reported that the next Regular School Committee meeting is scheduled on March 10th relating that the Committee will be talking about the proposed plan at that meeting as well.

Ms. Rossetti supports getting kids back in school full-time, inquiring what the primary drive is for not bringing them back full-time now.
