#### **Summer School Programs**

Assistant Superintendent Ms. Regan and Dr. Basteri presented a powerpoint presentation on the 2021 TPS Summer Programming. Ms. Regan reported that the summer programs are based on need, family participation and contingent upon staffing.

Mr. Pelletier presented the Special Education Extended School Year. Programming is in place for in-person and remote learning. He reported that transportation services will be offered.

The district will also offer summer transition and orientation programs for students grades 7-12, Remote Learning Academy (RLA) student orientation and transition, kindergarten orientation, and freshmen orientation. Ms. Regan reported that bussing is still being determined.

Mr. Sullivan opened for questions and/or comments from the School Committee members. The Committee thanked Dr. Basteri and Ms. Regan for the presentation. Mr. Sullivan is pleased that there will be transition and orientation programming. In response to a question from Mr. Sullivan, Ms. Regan reported that there are 38 kindergarten and first graders identified for the Kickstart Program adding that most programs are good to go (depending on staffing). She will provide an update at the July School Committee meeting.

#### CITIZEN'S FORUM

Mr. Sullivan inquired if any residents had signed-up wishing to speak on any item on the agenda.

- 2) Doreen Healy, Baldwin Avenue, Billerica: Ms. Healy commented that students having to wear a mask needs to end. She commented on the Summer School presentation regarding transportation as well as offering the Credit Recovery Program to students attending Shawsheen Technical High School.
- 3) Peter Foster, 156 Marshall Street, Tewksbury: Mr. Foster asked the School Committee members to advocate for the removal of masks in schools.
- 4) Leslie Rosetti, 682 South Street, Tewksbury: Ms. Rosetti commented that she is not in agreement with the mask mandate.
- 5) Julie Gonzales, 20 Bryant Lane, Tewksbury: Ms. Gonzales commented that there is no benefit to the mask.
- 6) Emma Tinckle, 46 Sycamore Drive, Tewksbury: Supports removing the mask from the children.
- 7) Lisa Wilson, 315 Lancaster Drive, Tewksbury: Ms. Wilson commented that she does not advocate for children to wear a mask.

## SUPERINTENDENT & STAFF REPORTS

## Mr. Malone, Superintendent

Mr. Malone thanked the retirees for attending this evening offering them congratulations on their success. He reported the district is using mitigation strategies in the schools to keep students comfortable due to the extreme temperatures, using hallway fans, air conditioning, moving students when necessary, and using the tents outside. Mr. Malone reported that as we approach the end of the school year, only a week from today, that some of the grants described in the Summer School Programming presentation just came out last week relating that it is extensive to plan, apply and arrange for the grants, offering thanks to Dr. Basteri and Ms. Regan. As a reminder, graduation is Friday, June 11th and it will be held outside on the field. Mr. Malone offered congratulations to Ron Drouin, Athletic Director. The National Interscholastic Athletic Administrator Association has announced that Mr. Drouin has been recognized as a NIAAA Certified Athletic Administrator. Mr. Malone reported that AlphaBEST will continue to offer programs in the summer and into the fall. They will be opening in the Rec Center and the Wynn Middle School. They will offer a Before and After School program in the fall. He reported that Field Director Dorothy Presser, of the Massachusetts Association of School Committees (MASC), held a training for our new School Committee members. He added that the 2021 TMHS Awards & Scholarship Night was held May 27th relating that there were several hundred thousand dollars in scholarships this year.

## Ms. Theriault-Regan, Assistant Superintendent's Report

Ms. Regan presented a few updates for parents reporting that the School Supply lists for K-8 have been updated on the school websites and that TMHS will inform the students at the start of school what supplies are needed. She reported that the virtual tours presented by the school principals will be posted on the respective school websites. Ms. Regan reported on the Acceleration Road Map, a new comprehensive tool for teachers designed to focus on a phased approach for the 2021-2022 school year featuring three priorities. She reported there will be summer professional development opportunities for staff and administrators. Ms. Regan announced that next Wednesday is the last day of school and an early release day for students and staff.

Mr. Sullivan opened for questions and comments from the School Committee.

## Mr. Libby, Business Manager

Mr. Libby provided the Committee with an update regarding the ESSER III Grant relating that the district was awarded \$2,771,743.00 as part of the American Rescue Plan (ARP). Spending related to the funding must be completed by September 24, 2024. It is a requirement of each city and/or town to make a safe return plan for students; we have already met that requirement. The district has to develop a Committee to see how to spend the funds. He added that we will be looking for stakeholder input on how to write the grant and the district will reach out to stakeholder groups early in the fall.

Mr. Sullivan opened for questions and comments from the School Committee.
