

Dear North Street Families,

Finally the weather looks more like what we expect in August, and I hope you and your family are enjoying the slower pace and opportunities for fun that the summer brings. Before we know it, the beginning of school will be upon us. I will be in touch closer to the first day of school (which is Wednesday, September 1st), but wanted to share some initial information with you ahead of time.

- Homeroom assignments are now available for view on Aspen. As a reminder, the login ID is all lowercase letters, and consists of the student's last name, first initial, and the last 2 digits of the year of graduation. If you have forgotten the password, you can email me or Mrs. Zaremba, our secretary, at szaremba@tewksbury.k12.ma.us. More information about Aspen, and the link, can be found on the TPS website, top tab "Resources" and then under "For Parents & Students."
- I am aware that there are two groups of students that have never entered our warm and welcoming school building: rising third grade students, and rising fourth grade students that were enrolled in the Remote Learning Academy last year. Although our Virtual Step-Up Day slideshow and video is posted on our North Street website (top tab "Resources" and then under "For Students"), it can not replace actually walking the building itself. I will be offering building tours on Thursday morning, August 26th, to those "new" students and their families at the following times:
 - Student Last Name beginning A G: 9:00-9:20
 - Student Last Name beginning H 0: 9:30 9:50
 - Student Last Name beginning P Z: 10:00 10:20

Please note that this will be a general tour of the building at its spaces, ending at the playground. We will not be entering teachers' classrooms nor should you anticipate meeting the teacher during these walk-throughs. The PAC will also be running a Playground Playdate during the same time frame (from 9:00 AM - 11:00 AM). During the tour and the Playground Day, parents are expected to stay with their children.

• For incoming third grade families, and any new families to North Street School, I will be hosting our annual Third Grade Orientation meeting. It will be held on Thursday, August 26th, in the North Street cafeteria, from 5:00 PM - 6:00 PM. This is an opportunity for our newest families to come to the school and hear a bit about how life is different for our third grade students from their previous school year.

In closing, I must acknowledge that there is uncertainty about the complete vision of what children and staff will experience this upcoming school year. For now, I am planning events with the information I have in front of me currently. When and if health advisories change, I will change my planning appropriately. Please look for more communications from me throughout the coming weeks, and don't hesitate to reach out with your questions.

1:1 Chromebook Learning Program

I am excited to remind families that all students at Tewksbury Memorial High School will be issued a Chromebook to be used in the coming school year and to be retained for their time as students at TMHS. This goal has been part of the long-term goals of the Tewksbury Public Schools to enhance technology as a teaching and learning tool, and the implementation of the 1:1 learning program seems to be a logical next step in the progression to reach this goal.

> New Students

Students who are new to the district will have a chance to meet with their school counselor either in person or through Zoom before school starts to create a schedule, to ask any questions they may have about TMHS, and to learn a bit about what student life is like at the high school. We look forward to welcoming you and helping you find your niche among our student body.

> Freshmen Students and Parents/Guardians

There will be a Freshman Parent Breakfast on Friday, October 1, at 7:45 a.m. in LGI-1 at TMHS for parents of 9th graders to welcome you and provide answers to some of the most commonly asked questions. A virtual presentation will also be posted online for parents who cannot attend. Additionally, counselors will be meeting with small groups of freshmen the week of September 20th to introduce themselves and explain some of the services we provide in the Guidance Office.

> Sophomore and Junior Students and Parents/Guardians

We are currently planning for an in-school administration of the PSAT for sophomore and junior students on Wednesday, October 13th. The PSAT is a practice exam for the SAT and is not required for college admission. Juniors and seniors interested in taking the SAT need to sign up on their own through the College Board Website (www.collegeboard.org). Keep in mind that many colleges continue to waive the SAT requirement for 2021-2022 applications. Most junior students do not need to take the SAT until the spring of 2022. TMHS will be offering an in-school administration on April 13th for TMHS students only.

> Senior Students and Parents/Guardians

There will be a Senior Parent Breakfast on Friday, Sept 24th, at 7:45 a.m. in LGI-1 for our senior parents to share important information about the college application process. Additionally, all senior students will attend the Senior Presentation in the auditorium that day to review the information that was shared during their Junior Meetings last spring. All senior parents and students should join the Class of 2022 Future Planning Google Classroom, which is updated weekly throughout the school year with important information related to postgraduate planning for all students. If you have not joined this classroom or need to know how to do so, please email your school counselor for the join code.

On Thursday, August 26th, from 12:00 noon to 1:30 p.m., the Guidance Department will host its annual Common Application Workshop in LGI-1 for all seniors planning to apply to college in the fall. Students should bring a laptop computer. A limited number of computers will be available on a first-come, first-served basis the day of the workshop. Students who cannot attend this workshop will be able to access a step-by-step tutorial in the aforementioned Google Classroom in early September.

As always, please refer to the Guidance section of the TMHS website for the most up-to-date information from the Guidance Office.

Student Advisory Block:

In the 2019-2020 school year, Tewksbury Memorial High School introduced an Advisory Block for all students. The Advisory Block will continue in 2021-2022. Students are randomly assigned to an advisory teacher for the time that they are a student at TMHS. The advisory groups will meet throughout the school year with a goal of fostering a positive school culture and personalizing all students' learning experiences. A major objective of the Advisory Block is to allow students time to figure out who they are, where they are headed, and how they are going to get there. Athletics

Registration and payment of the User Fee for Athletics for the fall athletics season must be done through Community Pass. (SWOL) <u>SportsWare</u> is open now to upload current physicals and any medical information.

Parents and students are reminded that sports physicals expire thirteen months from the date of the physical examination. Regulations issued by the Department of Public Health require that students have an up-to-date physical examination for their continued participation in athletics. This regulation mandates that upon the expiration of a student's physical examination, which is valid for thirteen months, the student is immediately not eligible for participation in interscholastic athletics until such time that a valid physical examination report is filed with the office of the Athletic Director. If your child's physical examination is due to expire during the athletic season or school year, make sure you schedule well in advance another appointment with your child's physician for a new physical examination so that your child remains eligible to participate in high school athletics.



On 07/21/2021 the Tewksbury School School Committee held an open meeting. I was denied access to this open meeting. Losing access prevented me from speaking publicly and from participating in providing a Committee update on the SEPAC, which was an agenda item. As a parent, I had previously received(07/14/2021) a letter from the Superintendent reqesting that I refrain from entering any Tewksbury Public School building beyond the lobby area without his knowledge and express consent. I was unsure if I would be able to make the School Committee meeting, as I work nights, but at the last minute I was able to attend. I contacted a parent who was in attendance and asked that they request permission that I be allowed into the school building so that I could attend and participate in the open meeting. The parent did ask during Citizen's Forum and was told that the School Committee would not entertain her request because it was not an agenda item, despite my being responsible for providing an agenda item later in the meeting. Additionally, School Committee Policy BEDH-E allows public comments: "Individuals may address topics on the agenda, items specified for public comment, or items within the scope of responsibility of the School Committee." There was no action taken and I was not granted permission to enter the building nor participate in the meeting.

On July 20,2021 I submitted a Public Records Request to the Superintendent of Tewksbury, Christopner Malone. The reuest was written as follows: "Please consider this email a public records request for all executive session meeting minutes for the School Committee during the 2020-2021 school year. It is my understanding that Policy BEDGB instructs you as Superintendent to review the session minutes on a regular basis and recommend to the SC the release of all or a portion of executive session minutes on a timely basis."

On August 2, 2021 I received the following response from the Superintendent, "Hello Ms. Wall,

In response to your July 20, 2021 Public records Request please understand that the 2020-2021 school year Executive Session minutes have not been approved by the School Committee as of yet and are in draft form. Approval of executive session minutes for the requested time period will be placed on the executive session agenda for the School Committee's August meeting, and a subsection (g)(1) determination will also be made regarding the approved minutes. The approved minutes or portions thereof that are not subject to a subsection (f) exemption will then be released to you. I received your request after the School Committee meeting for July 21, 2021 had been posted and, therefore, the matter will be taken up at the August meeting as noted above.

I allege that the Superintendent and the Chairperson violated open meeting law by failing to review and approve the meeting minutes in a timely manner. As you are aware, the Open Meeting Law requires that a public body "create and maintain accurate minutes of all meetings, including executive sessions, setting forth the date, time and place, the members present or absent, a summary of the discussions on each subject, a list of documents and other exhibits used at the meeting, the decisions made and the actions taken at each meeting, including the record of all votes." G.L. c. 30A, § 22(a). The meeting minutes must be reviewed and approved in a timely manner. G.L. c. 30A, § 22(c). The Open Meeting Law itself does not define "timely manner." However, in 2017 the Attorney General's Open Meeting Law regulations provided that "timely manner" means "within the next three public body meetings or within 30 days, whichever is later, unless the public body can show good cause for further delay." 940 C.M.R. 29.11 (2).10 Whenever possible, we recommend that minutes of a meeting be approved at the next meeting. See OML 2019-39; OML 2014-15; OML 2012-91. The requirement that meeting minutes be approved in a timely manner applies equally to minutes of executive sessions. See 940 CMR 29.11; OML 2019-115.

The above response to my public records request clearly show that for the entirety of the 2020-2021 school year the School Committee did not meet on a regular basis to review and approve the executive session minutes in a timely manner. Additionally, the Superintendent and the Chairperson did not meet on at least a quarterly basis to declassify the executive session minutes and make them available to the public.

I am gravely concerned that the Chairperson, the Superintendent and the School Committee neglected their obligations to create, review and release executive session minutes for at least a full school year and possibly longer.
