CALL TO ORDER

Keith Sullivan called the April 13, 2022, Regular School Committee meeting to order at 5:31 p.m.

EXECUTIVE SESSION

Mr. Sullivan entertained a motion to convene an Executive Session to review and approve the Executive Session minutes and to discuss strategy with respect to collective bargaining with employee groups and/or litigation or discussion of personnel matters. The Committee will also discuss Collective Bargaining with Teamsters (Custodians and Secretaries) regarding ratification on the School Committee side of the Contracts.

Ms. Garabedia moved, seconded by Ms. Biagioni-Smith, to enter into the Executive Session to review and approve the Executive Session minutes and to discuss strategy with respect to collective bargaining with employee groups and/or litigation or discussion of personnel matters. The Committee will discuss Collective Bargaining with Teamsters regarding ratification on the School Committee side of the Custodians contract and Collective Bargaining with Teamsters regarding ratification on the School Committee side of the Secretaries contract. The Committee will return in open session.

At 6:00 p.m., Mr. Sullivan entertained a motion to adjourn the April 13, 2022 Executive Session. Ms. Garabedian moved, seconded by Mr. Russo. The Committee will reconvene in open session.

Roll Call Vote - Voting Yes: Mr. Parsons, Ms. Garabedian, Ms. Biagioni-Smith, Mr. Russo, and Mr. Sullivan. All Aye. Unanimous vote. Motion carried 5-0.

REORGANIZATION MEETING

Ms. Regan reconvened the School Committee meeting and called the April 13, 2022 Reorganization meeting to order at 6:00 P.M.

PLEDGE OF ALLEGIANCE

Mrs. Regan asked the new School Committee members to lead in the Pledge of Allegiance.

Ms. Regan announced that the April 13, 2022 School Committee Reorganization meeting will be televised and recorded and may be viewed live on Comcast Channel 22 and Verizon Channel 34 or YouTube.com/TewksburyTV. Under the Open Meeting Law, the public is permitted to make an audio or video recording of an open session at a public meeting. Ms. Regan inquired if anyone in the audience was recording tonight's meeting to please identify himself or herself. Seeing no one, Ms. Regan moved onto the next order of business.

Ms. Garabedian accepted the nomination and thanked the Committee for their support.

Nomination of Vice-Chair

Ms. Garabedian entertained nominations for the position of Vice-Chairperson of the Tewksbury School Committee. Ms. Garabedian moved, seconded by Mr. Parsons, to nominate Mr. Sullivan for the position of Vice-Chair of the Tewksbury School Committee.

All Aye. Unanimous Vote. Motion carried. 5-0.

Nomination of Clerk

Ms. Garabedian entertained nominations for the position of Clerk of the Tewksbury School Committee. Mr. Sullivan commented that with past practice, the candidate with the most votes is nominated for the Clerk position, nominating Ms. Biagioni-Smith to the position of Clerk, seconded by Mr. Russo.

All Aye. Unanimous Vote. Motion carried 5-0.

At 6:20 p.m., Ms. Garabedian asked for a motion to adjourn the Reorganization meeting and reconvene the Regular School Committee meeting at 6:30 p.m. Mr. Parsons moved, seconded by Mr. Russo. All Aye. Unanimous Vote. Motion carried 5-0.

REGULAR SCHOOL COMMITTEE MEETING

Ms. Garabedian called the April 13, 2022 Regular School Committee meeting to order at 6:30 p.m.

MOMENT OF SILENCE

Ms. Garabedian called for a Moment of Silence in remembrance of Angela Kimble, former Principal of the North Street Elementary School.

Ms. Garabedian announced that the April 13, 2022 Regular School Committee meeting will be televised and recorded and may be viewed live on Comcast Channel 22 and Verizon Channel 34 or YouTube.com/TewksburyTV. Under the Open Meeting Law, the public is permitted to make an audio or video recording of an open session at a public meeting. Ms. Garabedian inquired if anyone in the audience was recording tonight's meeting to please identify himself or herself. Seeing no one, Ms. Garabedian moved onto the next order of business.

Ms. Garabedian welcomed our new School Committee members Kayla Biagioni-Smith and Rich Russo to the board. She turned the meeting over to Ms. Regan for recognitions.

RECOGNITION

Ms. Regan invited Commander Vinny Oliva and Sr. Vice- Commander Jimmy Williams of the Tewksbury/Wilmington VFW to the podium for recognition of the Patriot's Pen winners and the Voice of Democracy winner.

Tewksbury/Wilmington VFW 8164: 2021-2022 Patriot's Pen & Voice of Democracy Competition Winners

Commander Oliva congratulated the winners of the 2021-2022 Patriot's Pen and Voice of Democracy essay competitions. Olivia Jensen, Ryan Elementary School, for winning the Post competition, placing 1st in the District, and 6th place in the State. Ms. Jensen read her essay on "*How Can I Be a Good American*". Katelyn Murphy, Wynn Middle School, was recognized for placing 2nd at the Post level and 2nd at the District level. Brooke Bunyan, Tewksbury Memorial High School, was recognized for placing 1st at the Post level, 1st at the District level, and 4th at the State level. Commander Oliva introduced Kathleen Anderson, a teacher at the Ryan School who has been instrumental in encouraging students at the Ryan School to participate in the Patriot's Pen competition. He extended a thank you to the teachers in the district for encouraging students to participate in the essay competitions. The students received a citation and a scholarship from the VFW and a Resolution of Recognition from the School Committee.

TMHS DECA TEAM

Ms. Regan invited James Sullivan, DECA Team Advisor to introduce the team members. The DECA Team was recognized for their performance at the state competition and for qualifying for the International DECA Conference in Atlanta, Georgia.

Jim Sullivan offered a *Shout-out!* to Jack Stadtman relating that he was the first TMHS student, with Dr. Basteri, as a 4-year DECA state qualifier and finishing as a top ten qualifier. Mr. Sullivan thanked the parents for getting the hockey kids back and forth from the playoffs to the conference. Mr. Sullivan introduced the DECA State Champions: Mia Gaglione and Ava Gilligan, competed in the category of Project Management Community Giving; John Regolino and Michael Sullivan competed in the category of Business Law & Ethics.

Keith Sullivan commended the DECA students and moved the School Committee to approve an out-of-state field trip for the qualifying students to participate in the International DECA Conference in Atlanta, Georgia, seconded by Ms. Biagoni-Smith. All Aye. Unanimous Vote. Motion carried 5-0.

On behalf of the School Committee, Mr. Russo read and presented the students with a Resolution of Recognition.

STUDENT REPRESENTATIVE

Notes From Tewksbury Memorial High School

Jack Stadtman presented the notes from Tewksbury Memorial High School. This will be Mr. Stadtman's final meeting. The School Committee presented Jack with a parting gift after his report.

- As the week comes to a close, the students are anxiously awaiting April vacation.
- Members of Student Council were recently elected to new positions, including Jack's position; he will be replaced by a student from the sophomore class.
- The International Club planned an outdoor clean-up day last week and will do another in May.
- The Class of 2022 must have their dues paid and their permission forms submitted in order to participate in the senior events.

PRESENTATIONS

Dyslexia Presentation - Rick Pelletier, Director of Special Education

Mr. Pelletier addressed the School Committee members providing them with a presentation on dyslexia. He reported that the Special Education Department has been working to develop a foundation in spelling and reading for all students. He reviewed what dyslexia is and what it takes to support students with dyslexia. He said that the district has partnered with the Speech and Language Literacy (SAiL) lab at the Massachusetts General Hospital Institute for Health Professionals to strengthen our knowledge of dyslexia. We conducted a staff survey and offered professional development at the building level. The professional development has been presented to parents adding that representatives from MGH attended and presented the dyslexia PD. We have also partnered with the Landmark Outreach Program to provide lesson plans and instructional coaching and WESTED continues to provide co-teaching methodologies.

Mr. Pelletier responded to questions and comments from the School Committee members. He commented that MGH would like to come to a future School Committee meeting to present findings. The reports will be shared with the School Committee, the Tewksbury SEPAC, and posted on the district website.

Superintendent Search Committee Update - Dorothy Presser, MASC Consultant

Ms. Presser presented an update relative to the Superintendent Search and provided a recap of the process for the new School Committee members. SUPERINTENDENT & STAFF REPORTS

Ms. Regan, Superintendent

Ms. Regan presented a few updates, giving kudos to TMHS for hosting the SAT's for the juniors and seniors. Thursday, the high school will host the Junior College Fair in the morning and the Junior Prom will be held at the Tewksbury Country Club on Thursday night. The PACs are working on the All Night Long celebration for the Class of 2022, June 11th, 5:00 PM, at the Wynn Middle School. They are in need of volunteers.

Ms. Regan pointed out some information on the Consent Agenda. She reported the Central Office has moved into the Firehouse and we hope to get an occupancy permit for the new Center Elementary School in November and have the Central Office move into the CES. There are professional development days scheduled in March and April. The district is taking the pledge to stop sexual abuse; almost 100% have taken the pledge. Last week teachers administered the 3rd grade MCAS assessment and this week the 4-8th grade assessments will be administered. She announced that the district Annual Art Show is scheduled on May 6th & 7th and invited the community to attend.

Ms. Regan entertained questions and comments from the School Committee members.

COMMITTEE REPORTS

Elementary School Building Committee

Ms. Regan announced that the Elementary School Building Committee will be meeting tomorrow night. They have finalized the FFE list (furniture, fixtures, and equipment) and selected materials and colors. The project is on track and the ESBC are optimistic the maps are on time. OLD BUSINESS

FY 23 BUDGET

Mr. Libby reported on the FY23 Budget, he asked that the School Committee table changes included in Mr. Libby's memo. He reported that the Town Warrant was published without the changes. The Town Manager could divert to the budget details presented at the March meeting. He reported that the budget numbers we will be voting on tonight will be the same.

There were no further questions from the School Committee.

Mr. Russo moved, seconded by Mr. Sullivan, to approve the FY 23 School Budget in the amount of \$70,685,560.00. Roll Call Vote - Voting Yes: Mr. Parsons, Mr. Sullivan, Ms. Biagione-Smith, Mr. Russo, and Ms. Garabedian. Unanimous Vote. Motion carried 5-0.

OML Complaint Determination

Ms. Garabedian read the Open Meeting Law Determination (filed 7/21/2021) relating that the letter was sent on March 4, 2022. The OML Complaint from Sarah Steele, stated that the School Committee denied her access to the July 21, 2022 School Committee meeting. The Determination revealed that the School Committee did not break the Open Meeting Law.

Mr. Sullivan commented that the School Committee has received similar complaints afterwards, relating that the Committee had to ask people not to attend the meeting due to their behavior. He has requested that Ms. Regan report on the cost of attorney fees the district has incurred for Open Meeting Law (OML) complaints and Public Records Request (PRR) at the next School Committee meeting. He commented that OML complaints filed and the PRR have been taking time away from top administrators, resources, and money that could be spent on children.

Appointment of Valley Board of Directors

Ms. Regan reported that Mr. Malone was appointed to the Valley Board of Directors, requesting that the Committee motion to appoint her to the Valley Board of Directors. Ms. Biagioni-Smith moved, seconded by Mr. Parsons, to appoint Ms. Regan to the Valley Collaborative Board of Directors through June 30, 2022. All Aye. Unanimous Vote. Motion carried 5-0.

Out-of-State Trips Updates

2022 Domestic Trip to U.S. National Parks

Ms. Regan presented an update on the U.S. National Parks trip relating that the trip will depart on April 19th returning on April 25th, with 31 students.

2022 Costa Rica

2022-2023 School Choice

At the recommendation of the Superintendent, the School Committee voted not to participate in School Choice for the 2022-2023 school year in consideration of the work associated with the new elementary project, the uncertainty of continued operation of our schools, and student enrollment.

Mr. Sullivan moved to follow Ms. Regan's recommendation not to participate in School Choice, Mr. Parsons affirmed. Roll Call Vote - Voting Yes: Mr. Sullivan, Mr. Parsons, Mr. Russo, Ms. Biagioni-Smith, and Ms. Garabedian. All Aye. Unanimous Vote. Motion carried 5-0.

School Committee Representative to the Elementary School Building Committee (ESBC)

Ms. Garabedian reported that Ms. Demos and Mr. Stadtman were both on the ESBC, recommending that the School Committee consider allowing Ms. Demos to continue to serve on the Elementary School Building Committee as the School Committee designee. Mr. Sullivan also showed interest in serving on the ESBC.

Ms. Biagioni-Smith moved, seconded by Mr. Parsons, to appoint Ms. Demos and Mr. Sullivan to serve as the School Committee representatives to the Elementary School Building Committee. All Aye. Unanimous Vote. Motion carried 5-0.

Ms. Garabedian asked the Committee members to review the Sub-Committee assignments and let her know what they would like to serve on.

Mr. Sullivan offered congratulations to Kayla Biagioni-Smith and Rich Russo on their election to the School Committee. Mr. Parsons commented that he is excited about the new Committee. She gave a *Shout-out!* to the PACs for doing the Ice Cream Socials, Fun Runs, and Field Days.

Ms. Garabedian is looking forward to the plays at the end of the month at the Wynn and the high school and gave a *Shout-out!* to the Trahan School for their performance of *Peter Pan*.
