VOTE ON CONTRACT FOR AN ASSISTANT SUPERINTENDENT OF THE TEWKSBURY PUBLIC SCHOOLS

Ms. Regan presented the process the district undertook to appoint an Assistant Superintendent relating that Lori McDermott was unanimously chosen and considered the best candidate for the position of Assistant Superintendent.

Ms. Regan shared Ms. McDermott's background and employment history. Ms. Regan recommended that the School Committee appoint Lori McDermott as Assistant Superintendent of Tewksbury Public Schools, effective July 1, 2022. Mr. Sullivan thanked the people involved in the process to hire an assistant superintendent. He supports Ms. Regan's decision and hopes the other members of the School Committee do as well.

Mr. Russo moved, seconded by Ms. Biagioni-Smith, to appoint Lori McDermott to the position of Assistant Superintendent of the Tewksbury Public Schools, effective July 1, 2022.

Roll Call Vote - Voting Yes: Mr. Parsons, Mr. Sullivan, Ms. Biagioni-Smith, Mr. Russo, and Ms. Garabedian. All Aye. Unanimous Vote. Motion carried 5-0.

The Committee welcomed Ms. McDermott to the TPS and thanked the Westford Public Schools Superintendent and Assistant Superintendent for working with us to bring Ms. McDermott in quickly.

Ms. McDermott thanked the Committee and commented on the thoughtful hiring process.
