#### **Tewksbury Memorial High School Athletics**

Ms. Regan invited Ron Drouin, Athletic Director, to come to the podium to introduce the TMHS Athletes for recognition.

Mr. Drouin announced that the TMHS Wrestling Team, under the direction of Coach Kasprzak, are the Division 3 State Champions for the second year in a row. Members of the TMHS Wrestling Team come

# **Student Fees**

Mr. Libby, Business Manager, addressed the School Committee members presenting a Student User Fee Review. He reported that fees have not been reviewed in a long time. For this presentation fees include athletic fees, clubs fees and parking fees. He presented a historical expense breakdown, a financial analysis, and the impact of the free/and reduced lunch discount. He presented a comparison with 12 area districts relating that most districts had higher fees. He reviewed the MASBO Fee Survey reporting that Tewksbury is on the lower end of the fee structure. In the financial analysis, the goal is to cover increasing expenses. He proposed the fee increases that would put Tewksbury in-line with area districts. The next step will be for the Committee to vote on the proposal at the April 30th School Committee meeting. Mr. Libby responded to questions from the School Committee.

## **Superintendent's Report**

Ms. Regan reported that last week, she along with Ms. Milligan and Ms. Rawlinson, attended the Title I Conference. The MASC Day on the Hill annual event will be held on May 6th. She reported that the Valley Collaborative financial reports and newsletter are in the Consent Agenda. Ms. Garabedian offered congratulations to the Valley Collaborative for six exemplary audits. Also on the Consent Agenda is a donation to the TMHS Robotics team from the Teradyne Company; a thank you note will be going out to Teradyne for their generous donation. The end of year school events information is available for the School Committee members to view. Recent events include the performance of *Shrek* by the fourth grade class at the Center School and this week, the fourth graders participated in a live wax museum event. The TMHS Academic Excellence Awards will be held on April 29th at 8:45 a.m. Ms. Regan provided Ms. Biagioni-Smith with a reply to her question on sharing a firewall with the Town. The district firewall will be partially funded

by E-Rate; E-Rate is only for educational purposes and that prevents us from sharing costs with the Town. Ms. Regan announced that Meghan Corcoran has been appointed as the new principal at the Heath Brook School. She will join us at the April 30th School Committee meeting. We will hold a Meet and Greet prior to the School Committee meeting. She is hoping to announce the new principal of Ryan School the same night. Ms. Regan reported that Gail Johnson will be retiring on June 30, 2025.

# **Assistant Superintendent's Report**

Ms. Milligan reported that the Wynn hosted a Genius Hour and the students presented what they had learned. She thanked the teachers for supporting this opportunity for the students. Tomorrow is an Early Release day for students and a half-day Professional Development Day for staff. This is the fourth part of the Multi-Part Series. She gave a shout-out to the presenters for their work. On May 1st, May 2nd and May 3rd, the TMHS Theater Company will perform *The Little Mermaid*. Lastly, Report Cards for grades 5-12 will be posted in Aspen today.

### **Business Manager's Report**

Mr. Libby gave an update on an application which the school department submitted to the Department of Elementary and Secondary Education (DESE), for a Circuit Breaker extraordinary relief claim. If expenses are going to exceed 125% from the previous year, a district may apply and get money in the current year. Mr. Libby will keep the School Committee updated.
