CALL TO ORDER

Ms. Garabedian called the May 21, 2025 Regular Business Meeting to order at 5:32 p.m.

Ms. Garabedian announced that the May 21, 2025 Regular School Committee meeting will be televised and recorded and may be viewed live on Comcast Channel 22, Verizon Channel 34, or YouTube.com/TewksburyTV. Under the Open Meeting Law, the public is permitted to make an audio or video recording of an open session at a public meeting. Ms. Garabedian asked if anyone in the audience was recording tonight's meeting to please identify themselves. No one was recording the meeting.

RECOGNITIONS

2025 Ginsburg Family Award

Ms. Garabedian reported that the Ginsburg Family Award is for outstanding partnership with the Tewksbury Public Schools. The Ginsburg family has recognized groups and individuals that have had a significant impact on the district in the area of physical, tangible or monetary contributions and volunteering in the schools. She extended her gratitude to the Ginsburg family for their continued support and contributions to the Tewksbury Public Schools. Ms. Regan welcomed the Ginsburg's to the podium to present the award, announcing that Wicked Cheesy has been selected as the 2025 recipient of the Ginsburg Family Award. Nominated by Principal Andy Long, Athletic Director Ron Drouin, and Kimberly Nadeau, owners of Wicked Cheesy, Brian and Stephanie Schofield, were honored for their contributions to the Tewksbury community. Marc Ginsburg presented the Schofield family with an award and a gift to support the district in an area of their choosing. Ms. Garabedian thanked the people that nominated the Scholfield family; it was a tremendous nomination. Mr. Moncada read and presented a Proclamation of Recognition to the Schofields.

2025 Krissy Polimeno Outstanding Educator Award

Ms. Garabedian welcomed Krissy Polimeno to the meeting commenting that Krissy has been the most engaged and active community member for over 30 years and served 12 years on the School Committee. Ms. Garabedian reported that the Krissy Polimeno Outstanding Teacher Award is given to an educator that has had a significant impact on the Tewksbury Public Schools in the area of school involvement, volunteering, and giving time and energy to the quality of our education system. Who is also an advocate for students in schools. Ms. Regan invited Ms. Polimeno to the podium to present the awards, announcing that two educators were selected this year. Krissy Polimeno named Katie Buck, Kindergarten Teacher at the Heath Brook School, and Steve Boudreau, Physical Education Teacher at the Ryan Elementary School, as the 2025 award recipients. Ms. Regan presented a powerpoint presentation update on the 2024-2025 Special Education increased budget needs and the impact on our budget. The presentation illustrated the costs associated with servicing out students and sustaining a healthy budget for the Tewksbury Public Schools. Moving forward the district needs to advocate for more funding statewide for Special Education; Reorganize, expand, and align in-district TPS "pathways" at all schools district-wide; Focus on improved instructional supports for all students in general education; and Clearly communicate and continue to plan with our stakeholders. Ms. Regan, Ms. Tharrett, and Mr. Libby responded to questions and comments from the School Committee members.

SUPERINTENDENT & STAFF REPORTS

Superintendent's Report

Ms. Regan announced that the district was awarded the My Career and Academic Planning grant (MyCap) to support strengthening student pathways. She gave a shout-out to Dr. Basteri and Karen Baker O'Brien for securing the grant funding. AlphaBEST is offering district staff day-care opportunities, 6:30 a.m. through 4:30 p.m., for the 2025-2026 school year. There are 20 spots available; if the spots are not filled with TPS staff, they will be offered to the Town staff. Ms. Regan invited the School Committee members to attend the Scholarship Award ceremony tomorrow night at the high school. As a reminder to staff and families, Friday, May 23rd is an early release day for students and staff and Monday, May 26th, schools are closed in observance of Memorial Day.

Assistant Superintendent's Report

Ms. Milligan reported that Summer Programming information is included in the packet under Correspondence and Information Topics. One note in your packet, although Dr. Basteri is hopeful, we anticipate that the 21st Century Learning Penguin Pride Program, in our Pre-K buildings, may not run due to the lack of state funding. She provided an update on the Student Exchange Program at the high school, noting that 15 exchange students will be arriving in the Fall of 2025. Currently, six families have committed to hosting, but there is a need for nine additional host families. Those interested in hosting a foreign exchange student should contact Dr. Bailey Mahoney at Tewksbury Memorial High School.

Business Manager's Report

Mr. Libby reported that Bus Evacuation Drills information is included in the packet under Correspondence and Information Topics. The drills are conducted twice a year during morning arrivals. The drills have been completed reporting the schedule was changed to complete both front and rear doors drills on the same day. We are reviewing the Bus Safety Handbook and looking at safety at the bus stops in the morning. Mr. Libby gave an update on the upgrades to our infrastructure and wireless access points reporting that the district received the funds approved at the Town Meeting and E-Rate funding. The work has started and they hope to have the schools completed during the summer.

TMHS and Wynn Middle School Clubs & Activities' Fee is \$75; Individual Cap is \$300; Family Cap is \$450. Ryan School and Elementary Clubs & Activities' Fee is \$50; Individual Cap is \$200; Family Cap is \$300. He reported that going forward, fees will be reviewed annually.
